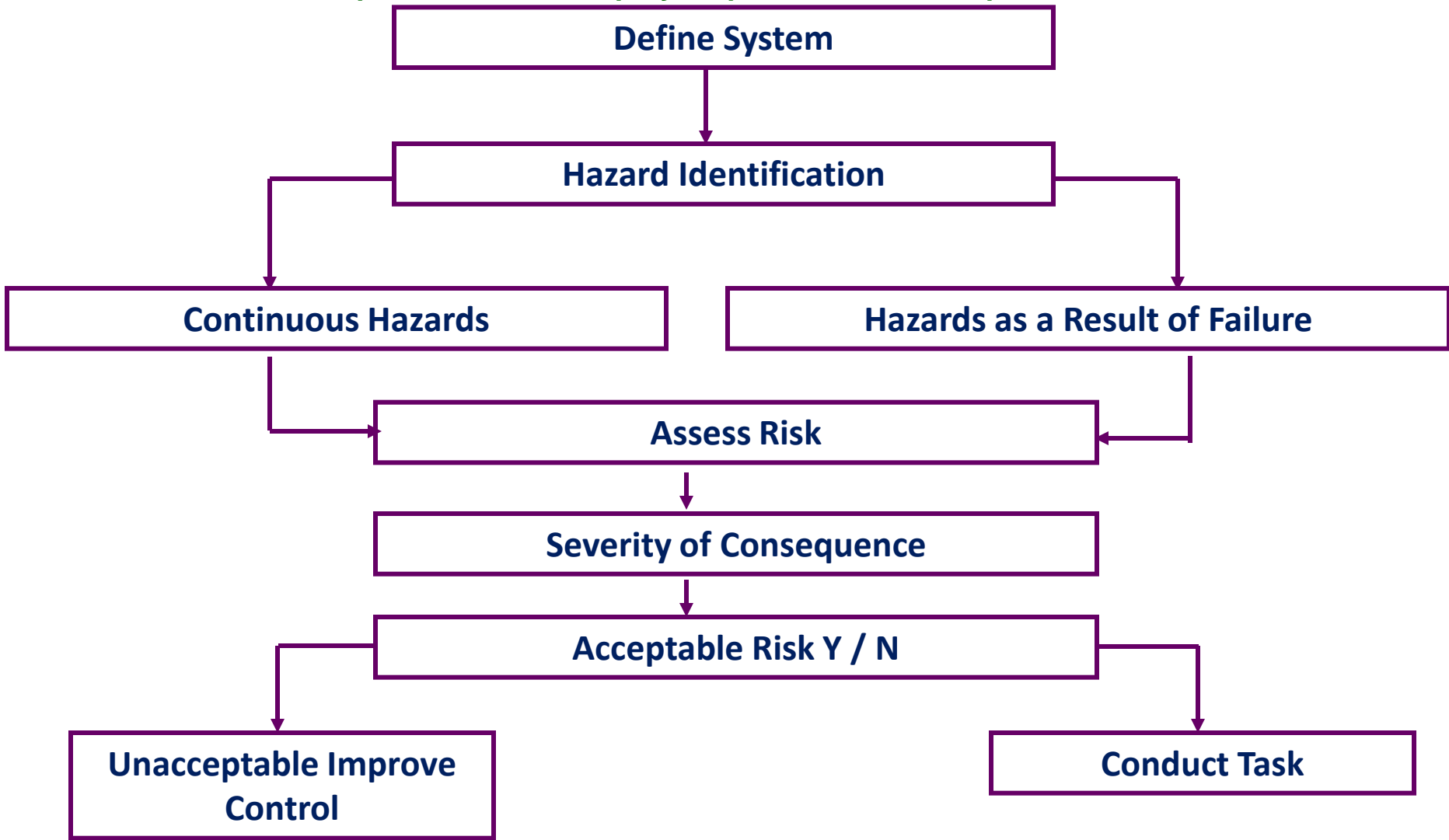

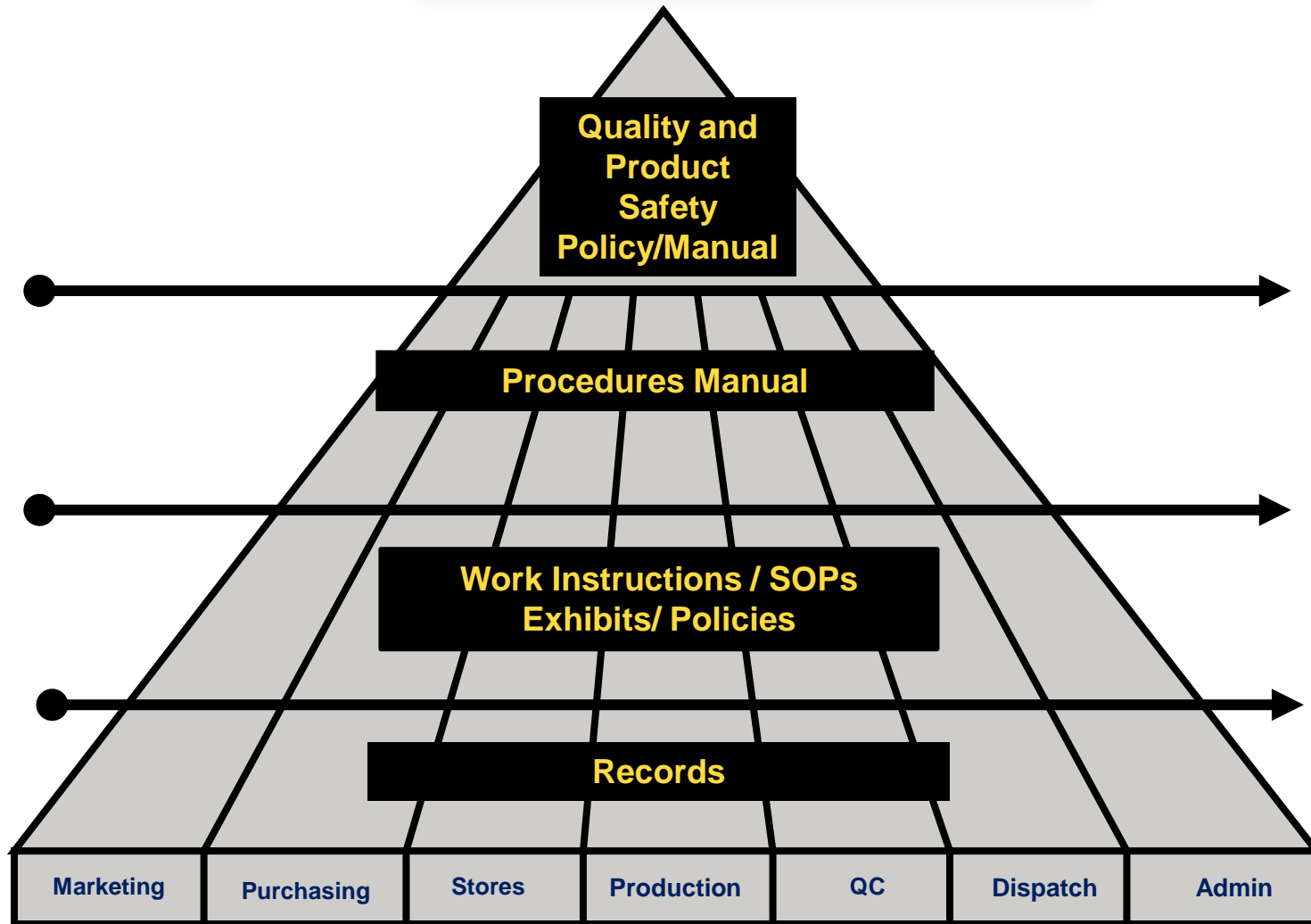
A schematic representation of step-by-step risk assessment process is shown here:

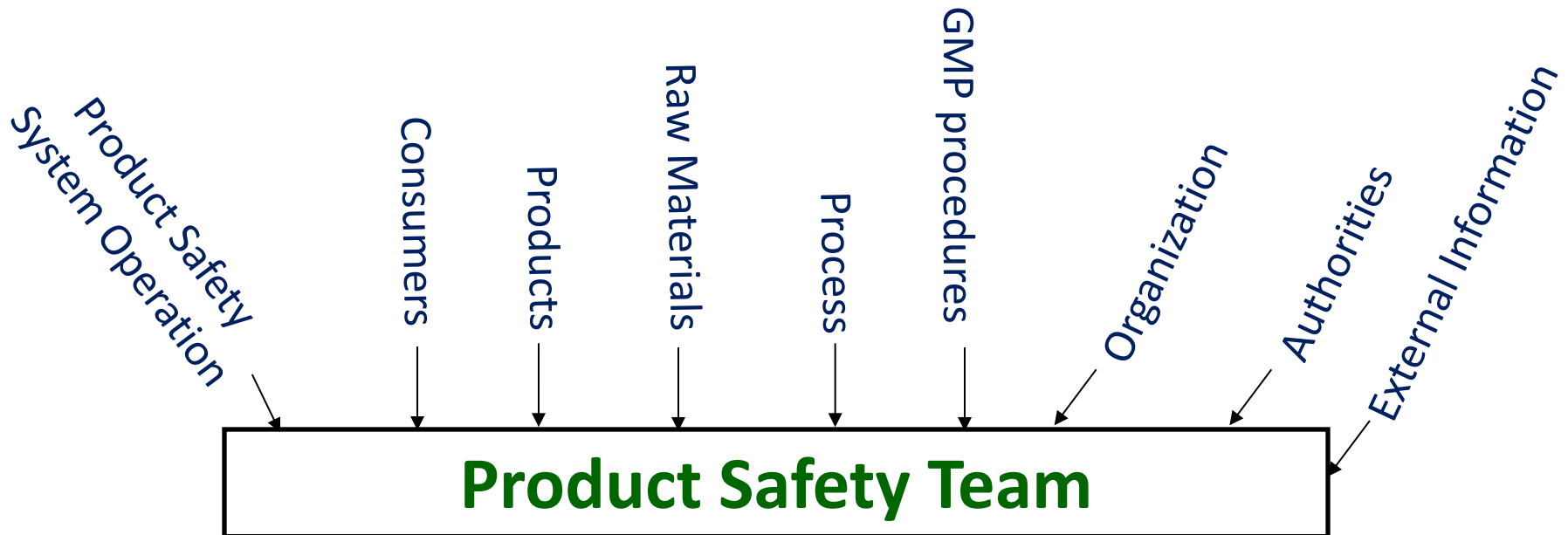

BRC Global Product Safety Management System Four -tier Document Structure

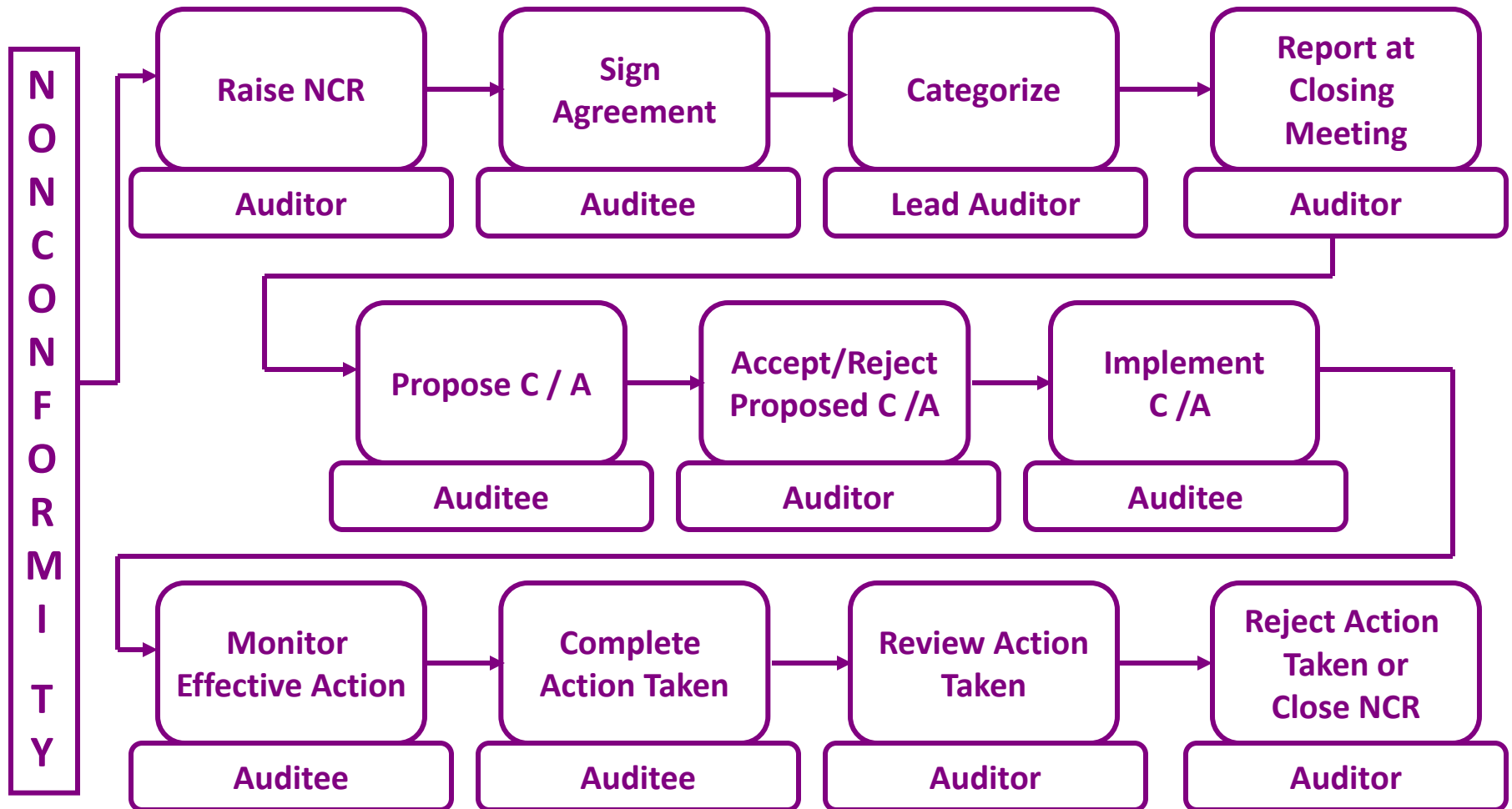


Updating of Preliminary Information and Documents Specifying PRPs and HACCP/HARA Plan
